Cong MLA's car runs over 47-yr-old man, driver held

A 47-YEAR-OLD resident of Ahmedabad was mowed down by a vehicle owned by a Congress MLA on Monday evening in Memnagar area of the city, after which the car's driver allegedly fled the spot.

According to the police, MLA Shailesh Parmar from Amraiwadi constituency, has claimed that his driver Devendra Bhavsar was behind the wheels when the accident took place. However, police have not arrested Bhavsar yet, after apprehensions were raised by the victim's family that the MLA is trying to protect another person who might have been involved in the accident and had presented his driver instead.

According to the police, the accident occurred around 6.45 pm outside Bhagirath society at Vivekananda intersection in Memnagar area, when 47-year-old Praful Patel — a resident of

Ghatlodiya area in Ahmedabad — was riding a Jupiter scooter and allegedly mowed down by a white-coloured Innova SUV with license plate GJ01RX9972. Police said that the vehicle's driver fled from the spot. Patel, a farmer by profession, succumbed to his injuries after the accident.

The police have not named any accused in the FIR which was lodged at A division Traffic Police station, since the car had a black film and nobody stepped out of the car after the accident, as per eye witnesses.

MLA Parmar said, "I was busy at an event on Monday evening and my driver Devendra Bhavsar had taken the car to do some household chores. No one else was present in the car except Bhavsar at the time of accident."

"The vehicle belonged to MLA Shailesh Parmar and on Tuesday morning, he claimed that his driver Devendra Bhavsar was driving the Innova SUV alone at the time of the accident. Bhavsar has surrendered him-

self, but we have not arrested him yet as we are not sure of the claims made by the MLA. We are going through the available CCTV footage and once it is clear who was driving the SUV, then we will arrest the accused," said PB Khamla, in-charge officer at the A division police station.

Income tax official, CA arrested for 'taking bribe'

THE ANAND Anti-Corruption Bureau (ACB) has arrested an official of the income tax department and a chartered accountant (CA) for allegedly accepting a bribe of Rs 10,000 for closing an individual's tax file of the financial year 2011-12.

According to the ACB, the accused officer, Kishore Rathod of Ward 1 of the I-T department in Anand, and Chartered accountant Pramesh Doshi demanded a bribe of Rs 50,000 to clear the IT returns of the complainant for the year 2011-12.

The complainant said that during the filing of the IT returns for 2011-12, the officer through the CA, demanded a bribe of Rs 50,000 after issuing a notice to the complainant to furnish all

bills and record books of the financial year. When Doshi promised to have the matter settled, he told the complainant that he would have to pay a sum of Rs 50,000 to avoid I-T scrutiny.

As per the complaint, he paid a bribe of Rs 25,000 through Doshi and the duo were pressuring the complainant to pay the rest of the amount soon. The complainant agreed to pay Rs 10,000 more towards the agreed sum to settle the I-T returns and also informed the ACB about the same.

The ACB has said in a statement that a trap was laid to nab the accused on Tuesday and Doshi was nabbed accepting the bribe from the complainant on behalf of Rathod. The ACB has also said that both Doshi and Rathod were to distribute the bribe amount according to a pre-decided share between them.

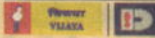
