

550 FAMILIES YET TO BE REHABILITATED

15 women from displaced families attempt suicide

A GROUP of 15 women from the displaced families of Kalyannagar slums that were demolished in November, 2014, attempted self-immolation on Friday to protest against the Vadodara Municipal Corporation (VMC) who "failed to rehabilitate them even after five years". However, timely intervention of police made sure that no untoward incidents happened. The women protesters were detained by the Vadodara police.

Ayesha Bano, one of the protesters, said, "Neither giving us our homes nor allowing us to die. It is very difficult as to affecting our livelihood a few hours for their homes in 2014, but it is taking

years for them to rehabilitate us. Why can't they just let us die?"

The VMC had, in November 2014, under the Smart City Project, demolished 1,921 homes belonging to poor and lower middle class families in Kalyan Nagar. Of the 1,921 families who were displaced, 1,440 were shifted to the Basic Affordable Housing Schemes (BSUP) housing in Tarsali, Pratapnagar, Maneja and Kishanwadi. The VMC decided to rehabilitate the remaining 550 Muslim families in houses built under the BSUP housing scheme in Sayajipura area in February 2015. However, they were

them in May 2015 to construct in-situ homes in Kalyannagar.

The VMC, which has now awarded the contract to Gayatri Construction after the previous contractor MV Omni turned out to be a bank defaulter, has set a deadline of March 2020 to rehabilitate the 550 families.

As many as 10,000 units for beneficiaries under various housing schemes like BSUP, Rajiv Awas Yojana (RAY) and Mukhyamantri Gruh Yojana (MGY) are awaiting completion due to the delay from the earlier contractor. The Standing Committee has directed the VMC to take action against the delay in completion of the project. The work on the Kalyan was suspended in when the VMC cited in April 2018, VMC agreed to restart the project.
